



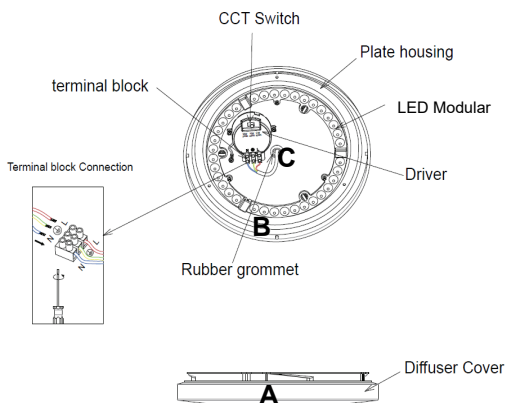

Installation Instructions:

1. Disconnect power
2. Remove diffuser 'A' by twisting anticlockwise.
3. Drill required holes in the ceiling using the holes in the fixture 'B' as a template.
4. Use screws and suitable fixture system to secure the fixture to the ceiling ensuring that the mains wire is through the entry hole 'C'
5. Connect the Active (L), Neutral (N) and Earth according to the markings on the terminal block.
6. Select Colour Temperature by toggling the switch on driver.
7. Re-attach diffuser 'A'
8. Restore power
